

## Entry requirements

Rules to travel to Italy from abroad

### DIGITAL PASSENGER LOCATOR FORM (dPLF)

#### Entries into Italy from all countries

If you arrive into Italy from abroad you must fill in an online **digital locator form (dPLF)**.

**The online form** is replacing the paper form which can be used in the event of technical issues.

You are **NOT required** to complete a COVID-19 Passenger Locator Form if you come from San Marino and the Vatican.

Starting from 24 May 2021, all passengers wishing to enter Italy, via all means of transportation, will be required to complete the **digital locator form (dPLF)**.

You can fill out this form by clicking on the button below, in advance of arriving in Italy.

#### How to fill out the form:

- go to the website <https://app.euplf.eu/#/>
- select 'Italy' as the destination country
- register on the website by creating a personal account, username and password, (this is required only if it is the first time you use the website)
- confirm the account via the link sent to the email address provided
- complete the form (dPLF)

Once completed, **an email confirmation** will be sent to the passengers.

Passengers will receive the **dPLF in PDF** and a **QR Code**, at the **email address provided during registration**, which should be presented when boarding and when required. **Alternatively**, passengers can **print a copy** of the dPLF.

**All passengers** are required to present a completed passenger locator form.

One form must be completed for each adult passenger.

**If minors are travelling with you**, they can be registered on the form of the accompanying adult.

**Minors travelling unaccompanied**: The dPLF must be completed by the parent or legal guardian before departure.

**PEOPLE TRAVELLING FROM :European Union, Norway, Liechtenstein, Iceland, Switzerland, Andorra, Monaco, Israel and United Kingdom of Great Britain and Northern Ireland.**

**In addition to the dPLF they are:**

- **Required** to have a **negative / 'not detected'** result from a pre-departure COVID-19 **PCR test or Antigen Test** taken within 48 hours prior to arrival in Italy.
- Required to notify the prevention department of the health authority responsible for the area of your entry.

**Failure to do so will result in:**

- Self-isolation for a period of ten (10) days at the address provided in the digital Passenger Locator Form
- Another molecular or antigenic test, carried out by means of a swab, at the end of the 10-day self-isolation

**People coming from ALL OTHER COUNTRIES NOT LISTED ABOVE:**

are now:

- **required to take a Covid-19 molecular or antigenic test** within 72 hours prior to entry (negative / 'not detected' result)
- Required to notify the prevention department of the health authority responsible for the area of your entry
- reach their final destination in Italy **only by private transport**
- undergo self isolation and health surveillance for 10 days.
- take another molecular or antigenic test, carried out by means of a swab, at the end of the 10-day self-isolation

### **COVID TESTED FLIGHTS**

UNTIL 30 OCTOBER 2021 Passengers on these flights, are authorised to enter and transit into the Italian national territory, without having to comply with the obligations of health surveillance and self isolation (*mandatory protocol apply*) . Passengers are no longer subjected to mandatory quarantine.
